145 Consolidated Aircraft Maintenance Squadron: Performs aircraft maintenance and related ground support equipment maintenance under supervision of Chief of Maintenance. Provides administrative support for assigned personnel, excluding personnel functions.

Units of the 145th Fighter Group (AD) (with exception of the 145th USAF Dispensary) were activated, and received Federal Recognition, 1 July 1957.

145th Consolidated Aircraft Maintenance Squadron was discontinued and inactivated 24 January 1964 and returned to the control of the National Guard Bureau..

As a result of this reorganization, subordinate units were effected as follows: Note: National Guard Bureau letter, AFOTM, Subject: Adjust of Unit Historical Records, North Carolina Air National Guard. dated 19 February 1965, stated that the 145th Consolidated Aircraft Maintenance Squadron will be redesignated to the 145th Materiel Squadron, effective 25 January 1964 and not discontinued.

The 145th Air Transport Group, NCANG was again reorganized and realigned effective 20 February 1965, as directed by Special Order G-l, Adjutant General's Department, State of North Carolina, dated 18 February 1965 and National Guard Bureau letter NG-AFOTM, Subject: Reorganization of Air Transport Units, North Carolina Air National Guard, dated 16 February 1965. Action directed was:

Inactivation of the 145th Materiel (AT), 19 February 1965.

Activation of the 145th Consolidated Aircraft Maintenance Squadron (AT), NCANG, 20 February 1965. Authorized strength: 6 officers and 235 airmen.

Following subordinate units of the 145th Airlift Group, NCANG, were redesignated as shown below, with no change in station, strength or gaining command, effective 1 March 1994.
