OPERATIONS

Constituted in the Organized Reserve on 15 October 1921, assigned to the 1st Balloon Wing (General Headquarters Reserve) (later redesignated as the 10th Balloon Wing), and allotted to the Third Corps Area. Initiated on 12 November 1921 with headquarters at Philadelphia, PA. Withdrawn from the Third Corps Area 11 January 1927 and allotted to the Fourth Corps Area. Shreveport, LA, designated 22 October 1929 as headquarters on reorganization, but the unit was never organized at that location. Relieved from assignment to the 10th Balloon Wing on 1 October 1933. Concurrently, reorganized and redesignated as Headquarters and Headquarters Squadron, 563rd Balloon Group. Disbanded 31 May 1942.
