MISSION

The mission of the 907th Tactical Clinic is to provide limited diagnostic and therapeutic service in general medicine, military public health, dental and veterinary service under field or combat conditions for tactical units. As a mobilization unit, the 907th Tactical Clinic has the potential capacity to provide 26 authorized personnel without equipment. In a place at a specific location and in a state of operational readiness within the most stringent time frame, upon notification for mobilization.

After mobilization they will deploy and maintain a sustained operation for a limited duration for the purpose of providing manpower augmentation for a 12 bed air transportable hospital, or provide replacement personnel for a fixed facility whose personnel have been deployed.

The 907th Tactical Clinic is located on the 1st floor of building 114 the former USAF Hospital. The clinic occupies the entire Administrative Wing of building 114.
