AMC activated the Air Mobility Warfare Center (redesignated from the USAF Air Mobility School) at Fort Dix, New Jersey, adjacent to McGuire Air Force Base, New Jersey. The AMC Commander, General Ronald R. Fogleman, championed the creation of a command-specific "center for excellence" that would provide "graduate-level training" in air mobility. Prototypes for such a facility in AMC existed elsewhere in the Air Force, including Air Combat Command's USAF Tactical Fighter Weapons Center at Nellis Air Force Base, Nevada." Initially, the center consolidated at Fort Dix instruction and training functions from seven geographically-separated AMC units: the USAF Air Mobility School at Scott Air Force Base, Illinois, and its unit locations at Scott; McGuire Air Force Base, New Jersey; Ellsworth Air Force Base, South Dakota (the former Tanker Tactics Center); and Fort Eustis, Virginia; the 1492d Air Transportation Training Flight at Travis Air Force Base, California; the USAF Mobility Center at Charleston Air Force Base, South Carolina; and the 314th Ground Combat Readiness Evaluation Squadron at Little Rock Air Force Base, Arkansas. Concurrently with the return of the C-130s from Air Combat Command on 1 April 1997, the USAF Combat Air Delivery School at Little Rock Air Force Base, Arkansas, was reassigned to AMC and the Air Mobility Warfare Center. The result was a command single point for advanced mobility education, training, and testing. The testing mission of the warfare center was facilitated by the 1 October 1994 activation of the 33d Flight Test Squadron, which assumed the flight test mission of the USAF Mobility Center and was the only flight test organization in AMC.

## OL A; Travis AFB, CA

New Commander for Air Force Expeditionary Center Maj. Gen. Frederick Martin assumed command of the Air Force Expeditionary Center at JB McGuire-Dix-Lakehurst, N.J., this week. Gen. Paul Selva, head of Air Mobility Command, presided over the Sept. 9 change-of command ceremony, according to McGuire's Sept. 11 release. Martin succeeded Maj. Gen. William J. Bender who ran the center since October 2010. "There is mobility happening everywhere on every continent of the globe," said Martin upon assuming command. He said the center builds relationships that lead to partnerships. Martin comes to the Expeditionary Center after a year as deputy director of the Office of Security Cooperation-Baghdad, Iraq. The center is the Air Force's center of excellence for advanced expeditionary combat support training and education. 2013

The United States Air Force Expeditionary Center at JB McGuire-Dix-Lakehurst, N.J., recently reunited with five former commanders in a day devoted to celebrating the center's heritage, according to a Feb. 10 release. "The opportunity to meet face-to-face with each of these former commanders and get their candid feedback about the USAF EC was invaluable and we were

privileged to host the event," said Maj. Gen. Rick Martin, USAF EC commander. Many of the five commanders, who served at the center between 1997 and 2010, noted how it has transitioned from a regular schoolhouse to a schoolhouse with responsibilities "equivalent" to a numbered Air Force, states the release. "When I was commander, we were simply a school house for the Air Force providing air mobility education as well as expeditionary training," said retired Maj. Gen. Richard Devereaux, who served as USAF EC commander from 2009-10. Devereaux said consolidating various organizations under "one very prominent commander" has been "a great development for our Air Force." The former commanders also were briefed on integrated technology and toured the building. 2014

Air Mobility Command is streamlining its contingency response force by creating a single East Coast operations group, one West Coast operations group, and an advisory group, according to a release. Reorganization of the 621st Contingency Response Wing will consolidate the six current groups (four contingency response groups and two contingency operations support groups) located at JB McGuire-Dix-Lakehurst, N.J., and at Travis AFB, Calif., into three: the 821st Contingency Response Group at Travis and the 621st CRG and 621st Air Mobility Advisory Group at McGuire, states the May 28 release. "These internal changes provide more leadership at the [noncommissioned officer] level, better define the roles and responsibilities in the wing, and assign a single point of ownership of the equipment that the CRW needs to provide rapid global mobility," said Maj. Gen. Rick Martin, commander of the Air Force Expeditionary Center at McGuire. AMC began implementing the changes on May 28 and expects complete all realignment actions by the end of June, states the release. The realignment does not alter the 621st CRW's mission or assigned assets. 2015
